# Financial Projections and Revenue Streams

**Breakeven Analysis:** With 40 experts/doctors (worst-case scenario), MCHC is expected to break even at the beginning of Year 2, with a cumulative profit of \$956,500 by the end of that year.

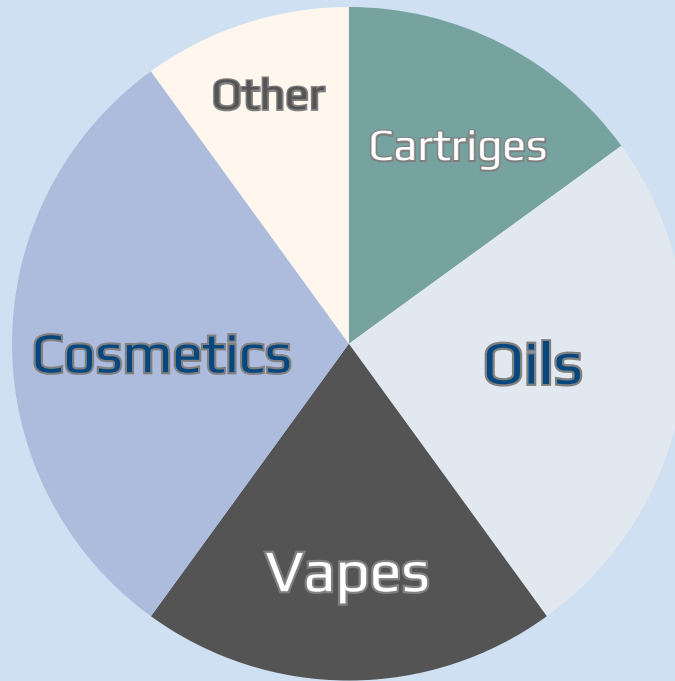

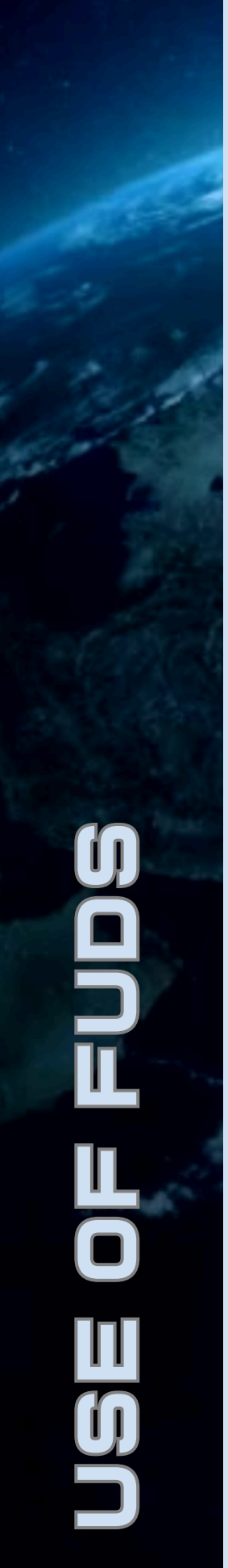

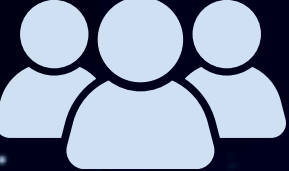
